





London Trade Mission to Poland

Located at the crossroads between Eastern and Western Europe, Poland is the largest of the new EU member states, with a population of 38m. Poland offers easy access to 250 million consumers within a radius of 1,000 kilometers and is the gateway to new markets and opportunities for trade and investment across virtually all sectors.

As one of the fastest growing economies in Central Europe, with an annual growth rate of over 6.0% before the latest recession, Poland was the only European Union (EU) member country to have avoided a decline in GDP and actually grew by 1.8% in 2009. Its economy is the sixth largest in the EU. Bilateral trade between Poland and the UK increased from £3 billion to GBP £7.3billion between 2003 and 2009.

EU Structural and Cohesion Funds will help maintain Poland as a market, offering growth, stability and good prospects for UK business. Poland's allocation of €67 billion will underpin investment in Polish infrastructure, environmental and technology projects, as well as supporting regional development.

There are business opportunities in a wide range of sectors including: consumer goods, healthcare, construction and transport infrastructure, engineering, environmental sector to include 'green' technology and waste management, IT and telecommunications, financial services, marine, and significant multi-sector opportunities as Poland is hosting EURO 2012 Football Championships.

This means you need to have fewer than 250 employees, and have a turnover of less than €50 million per year.
